INTRODUTION

Sicklecell Association of Uganda is a non-profit, non-governmental organization (NGO) that was founded by a patient in 2000 to represent the interests of sickle cell patients and their families. It advocates for the rights and responsibilities of affected persons. We work hand in hand with different stake holders to improve the quality of care for sickle cell patients. We also provide education and counseling to the sickle cell patients and their families about home care management.

In the year 2008, the General Assembly of the United Nations adopted a resolution which determines sickle cell disease as a public health problem and one of the world's foremost genetic diseases, requiring heightened awareness and activism, diagnosis and management. The result of the resolution was that June 19th was declared World Sickle Cell Day to increase awareness of the condition all over the world. The World Health Organization (WHO) has started work on a war footing to promote a worldwide agenda to address hemoglobin dysfunctions.

Sickle Cell Disease (SCD) is the most frequent genetic disease worldwide. It is present on four continents: in Sub-Saharan Africa and in the Maghreb, in Asia (Middle-East, Arabic Peninsula, India), in the Americas, on the North (USA), centre (Guatemala, Caribbean Islands), and on the South (Brazil, Surinam, and Guiana), in Southern Europe (Southern Italy and Sicily, Greece, Turkey). It is estimated that 500,000 are born every year with this severe and invalidating condition and that 50% of them will die before the age of 5 years. Trans-continental, SCD is also trans-ethnic and affects black populations from African origin and Arabic, Indian and Caucasian populations from Southern Europe.

It therefore upon this background that Sicklecell Association of Uganda started commemorating this day in 2010. This year Sicklecell Association of Uganda developed a proposal to Ministry of Health and was accepted with all proposed activities and theme and thus the Ministry of Health spearheaded the preparations and SAU brought on board her partners like Bank of Africa and her sister organizations working in Sicklecell disease such as Holly Foundation, Sicklecell Initiative, Uganda-American Sicklecell Rescue Fund, Sicklecell Information and Management, Joy for Joy foundation Luwero to Ministry of Health to be invited for involvement.

PLANNING FOR THE WORLD SICKLECELL DAY EVENT

Since this was a National event, Ministry of Health started preparatory meetings and brought on board World Health Organisation and Luwero District Local Government. We had weekly preparatory meetings from 8th May to 4th July 2013.

Sicklecell Organisations were charged to bring Sicklecell counselors to all the three Health Center IVs - that is Kalagala, Nyimbwa and Kasana for Sickle cell education, interpretation of results and counseling.

ACTIVITIES TO BE CONDUCTED INCLUDED:

- Sicklecell screening... the carrying out of a sickling test in Health Center IVs of the host district that is Nyimbwa, Kasana and Kalagala for the three days from 8th 10th July 2013.
- Health education about Sickle cell disease in the communities of Luwero District.
- Counseling to be provided for the screened people.
- Sicklecell football tournament for mass mobilization.
- Media engagement press release, press conference, radio and TV talk shows.
- Charity walk around Luwero town.
- Blood donation drive.

PARTNER'S COMMITTIMENT FOR THE EVENT:

- Ministry of Health was to pay 4 million for a pullout in newspapers, and 2 Million for a
 talk show on WBS television, provide technical support and facilitation to the Laboratory
 technologists in Luwero, provide reagents from National Medical Stores for Sickle cell
 screening for three days food, chairs and tents, and to contact Nakasero Blood Bank
- Bank of Africa to cater for trophies for the tournament, T-shirts and brochures on Sicklecell disease.
- Luwero District to host the event and mobilize the public to effectively participate in the activities.
- Each of the Sicklecell Organizations to provide five counselors for the provision of health education concerning Sickle cell disease, interpretation of the screened results and counseling.

• Holly Foundation to conduct mobilization and to make a speech on behalf of all Sicklecell organisations since it was based in the host District.

ACHIVEMENTS FOR THE WORLD SICKLECELL DAY EVENT 8^{TH} - 10^{TH} JULY 2013

 Ministry of Health commemorated World Sicklecell Day for the very first time in Uganda.

- ➤ She committed that Annual World Sicklecell Day celebrations will be held to carry out awareness of Sicklecell disease.
- ➤ She apologized on behalf of the Ministry that Sicklecell disease has received little attention and more effort will be given in future.
- ➤ Sicklecell clinics already established include; Mulago National Referral Hospital, Jinja regional referral Hospital, Kasana Health Center IV and Nsambya Hospital which is private.
- > To start up Sicklecell clinics in regional referral hospitals followed by Health Center IVs
- ➤ She advocated for couples to test for Sicklecell disease before marriage and make informed decisions.

- ➤ She further advocated for outreaches on Sicklecell disease to be conducted.
- ➤ She thanked us for the free airtime that was provided by media houses WBS Television, UBC Television and NBS Television.
- The Director General on behalf of Ministry of Health made a commitment to the following;

- o To commemorate world Sicklecell day every year.
- o To test for Sicklecell disease nationally and this will be done in the public laboratory by collecting blood samples beginning this financial year.
- A prevalence study on Sicklecell disease to be carried out this financial year for new data to be availed.
- o To conduct a research on pneumococcal vaccine.

- She emphasized that Sicklecell clinics will be opened in regional referral Hospitals.
- World Health Organisation gave financial support to Ministry of Health in preparation for World Sicklecell day.



Dr. Hafsa Kasule represented the WHO Representative to Uganda who is **Dr Wondi Alemu,** and advocated for the following;

- New-born screening, early treatment for Sicklecell patients, immunization, sensitization and nutrition should be emphasized.
- o To provide pneumococcal vaccines.
- Sicklecell disease should be integrated in research and this will reduce child mortality rates.

CHALLENGES AND GAPS

- The District and Ministry did not carry out the capacity building to the three Health Center IVs laboratory technologists.
- Reagents were not bought because National Medical Stores was closed for stock taking and claimed that they had supplied all facilities for two months.
- 98 people were turned away on Monday at Kalagala Health Center IV because of no reagents Ministry of Health bought reagents privately on Tuesday and 28 people were screened at Kalagala Health Center IV and 5 people at Kasana Health Center IV. On Wednesday 15 people were screened at Kalagala.
- Nyimbwa Health Center IV by 8th July 2013 was not aware about the Sicklecell screening program and referred SAU counselors to the district for clarification and thus counselors left frustrated.
- There are no established figures for Kasana on Wednesday 10th July, 2013.

- Mobilization was poorly done by the committed partners such that SAU had to put announcements on Tuesday night on community radios namely; radio Kalaso, Malaika and Wobulenzi to inform the public about the Sicklecell function on 10th July 2013.
- It was only Sicklecell Association of Uganda that brought Counselors from 8th to 10th July 2013. Most Sicklecell organizations did not even attend the event.
- SAU counselors received a negative attitude from Kasana Health Center IV staff on Tuesday to the extent that they had to counsel clients while seated on the grass yet counseling rooms were empty.
- T-shirts were selectively distributed to only Luwero district officials, a few patients and parents. The dignitaries for example State Minister, Director General, Commissioners, Professor, WHO representative, the exhibitors and the football teams did not get a single T-shirt yet they were very key.
- It was unfair that counsellors were not facilitated by Ministry of Health.

WAY FORWARD

- Transparency and accountability is ideal for all partners if we are to fight this dreadful disease in future.
- Next time Ministry of Health should facilitate active partners in terms of out of pocket allowances, transport and accommodation.

CONCLUSION

Despite the gaps Sicklecell Association of Uganda salutes Ministry of Health, World Health Organisation, Bank of Africa, Luwero District and Holly Foundation for the wonderful World Sicklecell Day.
